Athlete/Staff/ Spectator Requirements & the Assumption of the Risk & Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people. The health and well-being of our staff and athletes remains our top priority. To minimize the risk of COVID-19 entering our environment and spreading amongst our community, we will only allow a limited number of staff, athletes, & spectators to be in our gym. Individuals wishing to remain on site can use outdoor common areas or the parking lot to wait for their entrance or returning of their athlete(s). Staff, athletes, & spectators waiting to attend a session will need to wait outside while maintaining social distance from others. Furthermore, all individuals that enter the building for activities at the DELC or Armstrong Pavilion must agree to and abide by the following:

- •Submit to a self-check questionnaire
- •Submit to a Temperature check upon entrance

•Agree that there is an inherent risk of exposure to COVID-19 in any public place where people are present, and that COVID-19 is an extremely contagious disease that can result in severe illness or death. By visiting DELC/Armstrong Pavilion, you are voluntarily assuming all risks related to exposure of COVID-19

•Agree to follow the best practice policies and facility protocols set forth within the building has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in our gym environment; however, NUF cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at NUF could increase your risk and your child(ren)'s risk of contracting COVID-19.By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending NUF and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of NUF, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any activity.
